PSU NROTC COMMAND HISTORY



- 1926 Congress established NROTC and created 6 Units.
- 1943 the Navy College Training Program (V-12) was established at Penn State College.
- November of 1945, the NROTC scholarship program was established at the Penn State College.
- Since the Fall of 1945, over 3000 young men and women from Penn State entered the military service through the very successful NROTC program.
- Approximately 130 students are currently enrolled as members of the Penn State Battalion.

NROTC DOMAIN



- 77 individual NROTC Units
- 26 consortiums (multiple schools under one commanding officer)
- 5 departments at maritime academies
- 90 cross-town programs
- 167 colleges/universities with NROTC MIDN



- NROTC Scholarship:
 - Direct from high school (National Scholarship)
 - Three/Two year college accessions ("Sideload")
- **❖ NROTC College Program**
 - Direct input from high school and college
- **❖ Seaman to Admiral Enlisted Commissioning Program**
 - Specific designator (Nuclear, Aviation, EOD, etc)
 - Non specific designator
- Marine Corps Enlisted Commissioning Program



NROTC SCHOLARSHIP





- Full Tuition and Fees OR Room and Board
- *\$375 for books per semester
- Uniforms
- **❖ Monthly Stipend:**
 - \$250 for Freshmen
 - \$300 for Sophomores
 - \$350 for Juniors
 - \$400 for Seniors
- Committed at the beginning of Sophomore Year (1 September, 3/C Year)



SCHOLARSHIPS



- Gaining and Maintaining Scholarship Eligibility:
 - Academic Performance
 - Aptitude Performance
 - Physically Qualified
 - ❖ BUMED determines as informed by student. Student responsible for providing all information via NROTC Unit, Penn State.
- Placed on Probation or Leave of Absence (LOA) if eligibility not maintained
 - Disenrollment if deficiency not corrected
 - ❖ After beginning of sophomore year active service or monetary payback
- Leave of Absence:
 - All benefits removed
 - For Medical LOA can recover tuition



PROGRAM REQUIREMENTS



- Naval Science Classes (~1 per semester)
- 12 University Credits and 3 NavSci Credits
- Naval Science Laboratory (once per week)
 - Leadership Development, Guest Speakers, General Military Training
- Physical Training (PT)
- Physics/Calculus (Navy Scholarship)
- Swim Qualifications
- Summer Cruises



COLLEGE PROGRAM SCHOLARSHIPS




- College Program Students:
 - National Scholarship (31 Dec, less than 30 credits)
 - Sideload Scholarship packages submitted in June
 - Scholarships come from four year scholarship attrition
 - **❖Requires > 2.5 GPA to be eligible**
 - **♦> 3.0** to be competitive, better than "college" average
 - ❖Being successful at a Calculus course significantly improves selection
 - Excellent military aptitude
 - Technical majors (math, sciences, engineering) favorable
 - ❖Tier I/Tier II 85%


PSU NROTC SAT scores are significantly higher than national average!

*Many students retake Calculus and Physics due to "D"/"F" or Late Drop.


**Students removed from the program, or grades that were later improved, are not represented.

Privacy Act Statement

- 1. Participation in the Naval Reserve Officer Training Corps (NROTC) places me in a position of special trust and responsibility.
- As established by OPNAVINST 5350.4D, the abuse of drugs or alcohol violates this position of special trust and endangers my health and safety as well as the safety of others.
- In accordance with OPNAVINST 5350.4D, Naval Service Training Command (NSTC) maintains a "zero tolerance" policy regarding drug abuse.
 Additionally, all misconduct resulting from the misuse of alcohol will be dealt with immediately and effectively.
- 4. As a student participating or enrolled in the NROTC Program as a NROTC Midshipman (MIDN), NROTC College Program Student (Basic or Advanced), or Strategic Sealift Officer Program, I understand and agree to be bound by NSTC's policy regarding drug and alcohol abuse as reflected in the Regulations for Officer Development, NSTC M-1533.2D. Additionally, I understand I will be screened by urinalysis within 30 days of first reporting for training to the NROTC unit to which I have been assigned and may be subject to random urinalysis screening as directed by NSTC.
- 5. By signing the certification below, I acknowledge that a single detection of drug abuse or incident of alcohol abuse after entry into any program listed within paragraph 4 may result in my disenrollment or removal from that program, and, if on scholarship, either the recoupment of all scholarship monies I have received or Active Enlisted Service as may be directed by the Secretary of the Navy.

NROTC = Special trust and responsibility (not your average college student)

Even one incident involving drugs or alcohol abuse (i.e. underage drinking) may result in disenrollment. If on scholarship, this could mean a payback of money or enlisted service to the Navy.
